To: The Prospective Purchaser of Real Property in the Lomas Encantadas/Enchanted Hills Public Improvement District (the "District")

This is notification to you (the "Notice"), a prospective purchaser of real property in the District (the "Property"), prior to your entering into a contract with the seller to purchase the Property. The seller or an agent or broker of the seller of the Property is required to give you this Notice, which may be in addition to other notices or disclosures that may be required by federal, state or local law, and may request that you sign a copy of this Notice to indicate that you have received and read a copy of this Notice.

1. The Property is within the District, which is a public improvement district formed pursuant to the Public Improvement District Act, §§5-11-1 to -27, NMSA 1978 (the "Act") and City of Rio Rancho Resolution Enactment No. 26-54, Resolution No. 54 adopted July 13, 2016 (the "Formation Resolution").
2. The purpose of the District is to undertake certain Public Infrastructure Purposes (as that term is defined in the Act), including, but not limited to, financing certain Public Infrastructure (as that term is defined in the Act), including, but not limited to, financing certain Public Infrastructure Improvements (as that term is defined in the Act) through the sale of special levy bonds, reimbursement certificates, notes, or other debt instruments. Debt service on those special levy obligations is to be satisfied through a special levy imposed on the Property and all other property in the District in accordance with the Rate and Method of Special Levy Apportionment (defined in the Formation Resolution) as accepted and approved by the City of Rio Rancho (the "City") in the Formation Resolution (the "Special Levy"). The District may also finance all or a portion of the costs associated with the Public Infrastructure Improvements from the collection of the Special Levy, without the issuance of District bonds.
3. If you purchase the Property, you will be obligated to pay the Special Levy, and if applicable, any other property tax or special levy that may be imposed by the board of directors of the District (the "Board").
4. Any property tax or special levy imposed by the Board is in addition to any other state, county, or other local governmental taxes and assessments.
5. THE BOARD HAS AUTHORIZED THE IMPOSITION OF A SPECIAL LEVY ON THE REAL PROPERTY WITHIN THE DISTRICT. THE MAXIMUM SPECIAL LEVY THAT IS AUTHORIZED TO BE IMPOSED ON THE PROPERTY DURING THE DISTRICT'S FISCAL YEAR ENDING JUNE 30, 2021 IS IDENTIFIED IN THE FISCAL YEAR 2021 FINAL BUDGET, A COPY OF WHICH IS ATTACHED HERETO AS EXHIBIT 1 TO THIS NOTICE AND IS HEREBY INCORPORATED INTO AND MADE A PART OF THIS NOTICE. THE MAXIMUM SPECIAL LEVY IMPOSED ON THE PROPERTY MAY BE CHANGED FOR SUBSEQUENT FISCAL YEARS PURSUANT TO THE RATE AND METHOD OF APPORTIONMENT OF SPECIAL LEVY APPROVED BY THE BOARD, A COPY OF WHICH IS ATTACHED TO THE DISTRICT'S NOTICE OF

INFORMATION RECORDED ON DECEMBER 27, 2018 IN THE SANDOVAL COUNTY CLERK'S OFFICE AS DOCUMENT NO 2018028926.

- 6. THIS DISTRICT IS NOT AUTHORIZED TO ISSUE GENERAL OBLIGATION BONDS AND NO GENERAL OBLIGATION BONDS HAVE BEEN ISSUED.
- 7. FAILURE TO PAY THE SPECIAL LEVY, AND, IF APPLICABLE, ANY OTHER PROPERTY TAX OR SPEICAL LEVY THAT MAY BE IMPOSED BY THE BOARD COULD RESULT IN THE FORECLOSURE OF THE PROEPRTY.

## I. Introduction



---

This report provides details of the final Fiscal Year 2020-21 annual budget for the Lomas Encantadas/Enchanted Hills Public Improvement District (the "PID"). Pursuant to Section 5-11-23(F), NMSA 1978 (being a section of the Public Improvement District Act), the following required information is included herein:

- Estimated operation and maintenance expenses of the district;
- Cost of public improvements to be financed by the special levy;
- All other expenditures for public infrastructure improvements and enhanced services proposed to be paid from the special levy; and
- Amounts raised to pay special levy bonds if any.

Any capitalized terms used herein and not otherwise defined shall have the meaning ascribed to them in the Rate and Method of Apportionment of Special Levy (the "Rate and Method") accepted and approved by the City of Rio Rancho (the "City") pursuant to City Resolution Enactment No. 16-54, Resolution No. 54 adopted on July 13, 2016 (the "Formation Resolution").

## II. Estimated Operation and Maintenance Expenses



The PID will incur no operation and maintenance expenses with respect to public improvements. The PID will incur Operating Expenses in connection with the governance of the PID and the billing and collection of the special levies imposed by the Board pursuant to the Formation Resolution. Those Operating Expenses may include, but not necessarily be limited to legal, bookkeeping, audit services for the PID, bank fees, the PID Administrator's fees, and the County of Sandoval's costs of collecting the special levies. For Fiscal Year 2020-21, the final budget for PID operating expenses is \$53,492, and the detail is shown here in Table II-1.

### III. Cost of Public Improvements Financed by Special Levy



The Special Levy will not directly finance public improvement construction costs. Rather, the PID has entered into a Development and Reimbursement Agreement (the "Reimbursement Agreement") by and amongst the City, the PID, and Amrep Southwest, Inc., (the "Developer") with an effective date of July 13, 2016. Under the terms of the Reimbursement Agreement, the City and the Developer agreed that the Developer would design and construct all PID Eligible Infrastructure Improvements, and initially pay the cost of those improvements, along with the formation costs for the District. The City and Developer further intended that a portion of those costs would be reimbursed by the PID to the Developer by the District's issuance of Reimbursement Certificates payable by special levies. To date, five such Reimbursement Certificates have been issued by the PID, the details of which are summarized in Table III-1 below. The accrued interest, payments, and balances through June 30, 2020 are shown in Tables III-2 through III-6.

## V. Special Levy Collections



---

The budgeted FY 2019-20 special levies equal \$195,435. Gross distributions as of June 30, 2020 equal \$158,380. Assuming a delinquency rate of five percent (5.00%), approximately \$35,202 in additional gross distributions are anticipated<sup>1</sup>. Distributions less the County two percent (2.00%) collection fee are anticipated to be approximately \$34,498. Special levy deposits as of June 30, 2020 equal \$459,907. Of this amount, \$155,213 represents collections of FY 2019-20 annual special levies less County collection fees, and the remaining \$304,694 is attributable to prepaid special levies.

## VI. Annual Budget

## VII. Special Levy Methodology

---

All of the real property in the PID shall be subject to the Annual Special Levy for the purposes, to the extent and in the manner provided in the Rate and Method of Apportionment (the "Rate and Method"), unless exempted by the provisions thereof. The Rate and Method defines several classes of Property, including Undeveloped Property, Exempt Property, Platted Property, and Developed Platted Property. The Rate and Method further dictates that the Annual Special Levy will only be collected from Developed Platted Property, which is defined as any parcel for which a certificate of occupancy permit was issued as of April 30 and the Final Plat was recorded as of the preceding fiscal year. As of April 30, 2020, there are three hundred nine (309) residential properties within the PID for which certificates of occupancy have been issued and/or a field survey determined that a home has been completed and is occupied.

The Special Levy is apportioned to each parcel of Developed Platted Property in accordance with the designation of lot density prescribed in Table 1 of the Rate and Method. The Maximum Annual Special Levy and projected Fiscal Year 2020-21 Special Levy amounts are summarized by levy classification here in Table VII-1 on the following page.

Pursuant to the Chapter 115 of Laws of 2015, effective June 19, 2015, property owned by a disabled veteran, as defined in the legislation, is exempt from the imposition of a special benefit assessment, including the PID special levy, if the property is occupied by the disabled veteran as the disabled veteran's principal place of residence. In certain circumstances, the property owned by a surviving spouse of a disabled veteran may also be exempt from the imposition of a special benefit assessment if he or she meets the requirements of the legislation.

A listing of the FY 2020-21 special levy amount for each parcel in the PID is attached as Exhibit A.
